ORDINANCE 1, 2016

AN ORDINANCE TO VACATE A PUBLIC ALLEY IN THE CITY OF PERU

WHEREAS; A PETITION TO VACATE the North/South alley which is bound on the South by west Canal. This is bound on the east by parcel 52-08-33-117-020.000-016 and parcel 52-08-33-117-025.000-016, more commonly known as 321 W. 2nd Street in the city of Peru, Indiana, 46970. This alley is bound on the West by parcel 52-08-33-117-024.000-016 and parcel 52-08-33-117-021.000-016. After Public Notice and Public meeting on the 13th day of December, 2016 the City of Peru Planning Commission has not given its Favorable Recommendation and therefore submit their recommendation to the City of Peru Common Council for final action.

ORDINANCE 6, 2017

AN ORDIANCE AMMENDING THE BEE KEEPING ORDINANCE IN THE CITY OF PERU

WHEREAS; A PETITION to amend current city of Peru Ordinance:

151.066 RESIDENTIAL DISTRICTS

(M) The raising or keeping of bees shall be prohibited within the confines of the city limits or within 500 feet from any residence within the city jurisdiction.

(Ord. 5-2002, passed 3-4-02; Am. Ord. 22, 2008, passed 11-3-08; Am. Ord. 14, 2015, passed 4-6-15; Am. Ord. 16, 2015, passed 4-6-15

Proposed City of Peru Ordinance:

Bee Keeping Within Peru City Limits

It shall be unlawful to keep more than the following number of colonies on any tract of land, based upon the size or configuration of the tract on which the apiary is situated:

- a) one quarter acre or less two (2) colonies
- b) more than one-quarter acre but less than one-half acre four(4) colonies
- c) more than one-half acre six (6) colonies

Any structure used for apiculture shall comply with the following yard and setback requirements:

- a) Be located in a side or rear yard
- b) Bee hives may be located on the roof of a building with a permanent foundation.
- c) Be located at least 10 feet from any property line
- d) Hive Type All honey bee colonies shall be kept in Langstroth-type hives with removable frames, which shall be kept in sound and usable condition.
- e) Fencing of Flyways In each instance in which any colony is situated within 25 feet of a public or private property line of the tract upon which the apiary is situated, as measured from the nearest point on the hive to the property line, the beekeeper shall establish and maintain a flyway barrier in the following manner so that all bees are forced to fly at an elevation of at least six (6) feet above ground level over the property lines in the vicinity of the apiary. Any fence shall comply with SECTION 501 FENCE REQUIREMENTS and the following: 1) Height: six (6) feet in height 2) Materials: consisting of a solid wall, fence, dense vegetation or combination thereof that is parallel to the property line 3) Location: extends 10 feet beyond the colony in each direction
- f) Water Each beekeeper shall ensure that a convenient source of water is available to the bees at all times during the year so that the bees are less likely to congregate at swimming pools, pet watering bowls, bird baths or other water sources where they may cause human, bird or domestic pet contact.
- g) Queens Beekeepers are strongly encouraged to maintain all colonies with marked queens. In any instance in which a colony exhibits unusual aggressive characteristics by stinging or attempting to sting without due provocation or exhibits an unusual disposition toward swarming, beekeepers are encouraged to promptly re-queen the colony with another marked queen. Queens shall be selected from European stock bred for gentleness and non-swarming characteristics.

After Public Notice and Public meeting on the 14th day of February, 2017 the City of Peru Planning Commission has not given its Favorable Recommendation and therefore submit their recommendation to the City of Peru Common Council for final action.

Ordinance 7, 2017

AN ORDINANCE TO AMEND WAGE ORDINANCE 30, 2016
