11:30am: Call meeting to order: Antonia Sawyer-

- Introductions were made. Jennifer Yates spoke about the grant she has received, and she is from the YMCA. \$200,000 grant focused on prevention for Miami County. Next meeting is December 12, 2016 @ 5pm. Main Street United Methodist Church in basement.
- Brenda Morgan spoke about Health and Wellness Fair to be held November 17, 2016 @ 10:00am-2:00pm. Free to community.
- Amend minutes to correct John Walker title from executive to assistant director; Miami County Substance Abuse Coalition needs to be added to sector list; Todd Burns name needs changed from Burus to Burns.

11:45am-12:20pm: Discussion/Decision to have Jayme Whittaker come back in January or wait until needs assessment is complete?

- It was decided that Jayme would come back later in the year once the needs assessment was complete. This was decided based on the desire to have data for Jayme to help decipher and implement. The coalition will exchange the community assessment and secondary needs assessment/community resource guide to begin looking into what the

needs are, what questions to ask and who to ask them to. It was also discussed that once the needs came it, it would be easier for the coalition to build a vision-mission statement.

- Coalition would like to reach out into the community and see what the needs are. Local System Coordinator and coalition will look for more data pieces and needs assessments that have been done in the past three (3) years.
- Antonia Sawyer, BS passed out copies for the community assessment and then agreed to send electronically to the group. The assessment shows trends within the community.
- Coalition will look over secondary needs assessment and Miami County resource Guide to include any missing data. This will then be forwarded to Mayor Greer/Peter Diedrichs for website application allowing community access to all resources available in the community. It will be decided at a later date who will access that site for updates.
- All information to be placed on website will be forwarded to 2-1-1 to ensure they have an updated version of the guide.
- Between now and January: Antonia will continue to reach out to the community in an effort to grow the coalition. The coalition will continue to voice those they wish to see join the coalition/discussions happening at the meeting.
- Coalition requested a list of all individuals at the meeting and their job description/contact information. It was agreed that phone numbers could be added to list.
- Next month's meeting will host Four County Counseling Center Directors to discuss services and new "up and coming" programming. This topic was requested at last month's meeting.
- Todd Burns was unable to attend, Antonia presented results of information provided by Todd. It was discussed that Narcan/Naloxone only prevent substance abuse toxicity if not paired with benzodiazepines. Basic Life Skills (BLS) would be a good training for community and first responders outside of the EMS position. Community is mostly aware of Narcan/Naloxone not Flumazinl, a benzodiazepine reversal medication. Police are unable to carry Flumazinl, resulting in an inability to revive a victim.
- It was requested Flumazinl be researched as well as how to resupply EMS-Police with Narcan once used. Cost has risen making it available not accessible. Mayor asked if anyone was receiving "pushback" on Narcan as he had.
- Is it possible to supply masks to first responders who would learn BLS? Antonia will look into Lifeline Access grant.

12:30pm: Antonia Sawyer presented Miami County Transportation Effort to coalition. Mayor stated he has a bike committee and was interested in sharing with them. Mayor showed interest in participating in the proposal tomorrow with Debi Wallick. Mayor will be putting in bike lanes through Miami County and is interested in encouraging community to use them. Debi Wallick motioned for the transportation effort, Pastor Lauren Hall second. The coalition as a whole voted for the project and established a work group to focus on access, application and population. Mayor requested coalition to locate areas around Miami County that would need bike racks made accessible.

- Transportation work group includes: Zac See, Pastor Lauren Hall, Chief Michal Meeks, Kristi Eddy, and a member from First Presbyterian Church.
- This group will work toward a name, application, and access process to present to the coalition until it has been formalized and voted on.
