11:30am: Meeting called to order by Antonia Sawyer, Local Systems Coordinator. Introductions were made and Connie Shapiro agreed to take notes.  
July SOCGC meeting moved from original date of July 11, 2017 to July 18, 2017 due to Antonia Sawyer being on vacation.

11:35am: Rapid rehousing workgroup updated SOCGC. There has been an MOU signed between Advantage Housing and SOCGC to continue to move forward with the Rapid Rehousing (RR) grant. Wendy Langer has reached out to each local hotel/motel in county and is trying to gain a reduced rate or free room for those entering the RR program. As they are homeless and need a place to stay as they get housing arranged. Data from 2-1-1 has been obtained and shows need for the RR grant in our community. Debi Wallick and Antonia Sawyer will look into other grant opportunities to further sustain RR. Debi Wallick and Mayor Greer will meet with local banks and discuss community reinvestment act credits that we may be able to put toward the RR match funds.

11:45am: Bridgett Richardson and Amber Grover presented a "Walk for Recovery" to the SOCGC. They would like to start the walk at 10am and have the walk from the ballpark to the event center. They would like a banner and balloon signing at the walk and then release at the

event center. The walk will be during the SAPC recovery Month Celebration on September 16, 2017. And will be a community event in memory of those lost to addiction or those in recovery. Mayor Greer needs a map of the walk to get permission from the board of commissioners to ensure streets are blocked as needed.

12:00pm: CJ Davis and Dr. Kathleen Miller discussed Four County Counseling Center discussed their MAT-Rx program.

12:35pm: Brian VanCamp discussed needed support from SOCGC to move forward with the Commissioner meeting to gain support for the Narcan sustainability projects he and Antonia Sawyer have been working toward. The Commissioner meeting is June 20, 2017 @ 10:00am. Debi Wallick first the motion to support Brian VanCamp and Wendy Langer second the motion; it was a unanimous vote yes to support the moving forward with Narcan sustainability project. Brian will update group after the Commissioner meeting next week.

Updates: Wendy Langer announced a community meeting scheduled for June 13, 2017 @ 6:30pm. This will be to discuss a new soup kitchen.

Living Free has a website and classes scheduled to begin. The website information will be added to both the county and city websites.
