#### **ORDINANCE 15, 2023**

#### AN ORDINANCE TO AMEND ORDINANCE 8, 2018

WHEREAS, the City of Peru has caused public notice to be placed in the Peru Tribune. WHEREAS, Section 36.02 of the City of Peru Code of Ordinances shall be amended to reflect necessary changes.

**WHEREAS**, Section 73.14 of the City of Peru Code of Ordinances regulates the parking of Oversized Vehicles on city streets and or in alleys.

WHEREAS, the passing of Ordinance 8-2018 removed specific language under Section 73.99, which was the penalty section which gave the Police Department the authority to write fines and

penalties for Oversized Vehicles, which is an oversight and was not the intention of the City Council when adopting Ordinance #8-2018.

WHEREAS, Section 36.02 of the City of Peru Code of Ordinances shall be amended to reflect:

(F) – Any person receiving a ticket or notice of a parking violation under PMC Section 73.14 – Oversized Vehicle Parking, shall be fined \$150.00 for the first offense, and an additional \$25.00 for each subsequent offense, but not to exceed \$250.00.

## NOW THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF PERU, INDIANA, That:

- 1. It is in the best interest of the City of Peru to amend Section 36.02 of the City of Peru Code of Ordinances.
- 2. To reflect the necessary amendments to Section 36.02 of the City of Peru Code of Ordinance Book, said Section shall add Section (F), which shall read as follows: (F) Any person receiving a ticket or notice of a parking violation under PMC Section 73.14 Oversized Vehicle Parking, shall be fined \$150.00 for the first offense, and an additional \$25.00 for each subsequent offense, but not to exceed \$250.00

#### **ORDINANCE 16, 2023**

#### AN ORDINANCE TO VACATE A NORTH/SOUTH ALLEY IN THE CITY OF PERU

WHEREAS; A PETITION TO VACATE a proposed road on the property of 89 E Warren St Parcel # 52-08-34-101-034.000-023 Legal description 022-14426-00 STUTS 2<sup>nd</sup> AD; LOT 20 44 144 02600. After Public Notice and Public meeting on the 27<sup>th</sup> day of June 2023 the City of Peru Planning Commission has given its **Favorable/Unfavorable** Recommendation and therefore submits their recommendation to the City of Peru Common Council for final action.

- petitioner Teresa Williams. All existing Easements now in effect will continue in perpetuity.
- **SECTION 2**: Said Road is not necessary for the development growth to the City of Peru, Indiana. That such proposed vacation is for the public good.
- **SECTION 3**: Public Utilities for Electric, Gas, Phone and Cable have given their approval and all easement rights to this developed street remain in effect for the above.
