■ Joshua Sibert, contractor for BBS Homes, went in front of the board and said that a lot of the property is about half an acre and DNR requires the house to be 2 feet above the base flood elevation. As of now, the house is about 3 feet above the neighbor's property, and they have had to do some steep mounding to follow the DNR regulations within the Floodplain. He explained that the garage floor would be 0.7 feet underneath the Base Flood Elevation. The Board approved the request, 4-0.
