A request was made by MCEDA for \$35,000 to help fund the SMART Manufacturing pathway lab at Ivy Tech, this would benefit all 3 county schools. Jim Tidd explained that this lab will assist students in learning the manufacturing industry for students, it could also be used to benefit adults or manufacturers for training.

COMMUNICATIONS:

The airport is requesting to transfer one of the plow trucks being replaced to the airport to help them plow the runway. Mayor Struch stated he would look into that.

There being nothing further, Councilperson Anderson moved to adjourn the meeting, seconded by Councilperson Ulery. Motion carried.
