Anderson- Fire Department had 97 runs, 9 fires, 62 medical and 26 calls for service

<u>Fisher</u>- Attended both 7/15 Board of Works Meetings where claims and payroll were approved along with street closures. Attended 7/16 Utility Service Board meetings where talks about the long-term service plan continue to be discussed along with recent outages. MCEDA meeting on 7/9, Recycle 7/21 where the apron on Logansport Road has been completed, 7/21 Rediscover Downtown Cole Porter Festival, alley activation, ribbon cutting was held on 7/12 for the Acrobat Alley next to Flagstar Bank. Attended the groundbreaking for Dickey's carwash on 7/17 and also attended budget meetings with department heads on 7/31.

<u>Huber</u>- Kelly at the Airport states the groundwork for the hanger is complete and waiting on the State to come and inspect. They had to cancel the open house and will not reschedule this year. Greg at the Animal Shelter currently has 9 dogs 2 are out on home trials and appear will be adopted. He will be present at the next Second Saturday event with a few dogs that are available for adoption in hopes of getting them adopted as well.

<u>Murphy</u>- was unable to attend the Park Board Meeting 7/10, however she did get caught up. Clubhouse is currently selling alcohol as of 7/2/25, the irrigation project was started and is about 50% complete, Riverwalk bathrooms are complete and the Splashpad is to be completed in mid-August.

<u>Sahaidachny-7/15</u> attend the Board of Works meeting, 7/15 Miami County Council accepted bids to demo the Grissom Inn on base the lowest bid came in at \$177,000, they are also discussing the increase of the wheel tax. An ordinance to amend Ordinance 6 2014 stating if an alarm system fails that there must be someone notifying the fire department stating who will be on fire watch, if there is no one then the fire department will provide someone at the cost of the employee's hourly wage plus any overtime set by the city wage ordinance. Moved by Councilperson Anderson, seconded by Councilperson Stevenson, to suspend the rules and to adopt the ordinance in one meeting. Vote 7-0, MOTION CARRIED.

# ORDINANCE 20 - 2025 AN ORDINANCE TO AMEND ORDINANCE 40, 1989

An ordinance to amend Ordinance 40-1989. Amending that all fire protection facilities and fire hydrants required to be installed hereunder shall be approved by and meet the specifications of the Peru Fire Department and the Peru Municipal Water Utility as to location, connection size, type of material, and the manner of installation. All hydrants shall be equipped with a 5" Storz and 2-2.5" NST connections. All sprinkler external connections shall be 5" Storz on a 30-degree angle 30" from the ground. Internal standpipe connections shall be equipped with a 2.5" NST connection with a shut off valve. Moved by Councilperson Anderson, seconded by Councilperson Ulery, to suspend the rules and to adopt the ordinance in one meeting. Vote 7-0, MOTION CARRIED.

A motion was made by Councilperson Anderson, seconded by Councilperson Stevenson to consider Ordinance 18-2025 vote 7-0 in favor.

ORDINANCE NO. 18- 2025 AN ORDINANCE AUTHORIZING THE ENTERING INTO OF A CONDITIONAL PROJECT EXPENDITURE AGREEMENT OF CITY OF PERU, INDIANA (PERU APARTMENTS LLC), AND THE DISPOSITION OF THE PROCEEDS THEREOF TO PERU APARTMENTS LLC, AND AUTHORIZING AND APPROVING OTHER ACTIONS IN RESPECT THERETO. This would give Peru Apartments LLC 70% of the incremental accessed value back to them. The city would continue to receive the base accessed value which currently is \$3300. Moved by Councilperson Huber, seconded by Councilperson Sahaidachny, to suspend the rules and to adopt the ordinance in one meeting. Vote 7-0, MOTION CARRIED.
