RESOLUTION #2-2020

Josh Chance, General Manager of Peru Utilities presented the first reading of Ordinance#6-2020 to the Council. Josh explained that this ordinance would only affect those residents of the Grissom Aeroplex and not the residents of the city of Peru. Ordinance#6-2020 will be ready for consideration in the March meeting.

Parkview resident, Cynthia Stewart, addressed the council on the concerns she is having with water getting into her crawl space. After explaining how, after the streets were repaved, this problem has become more difficult to resolve. After hearing her presentation of all that she has done and the expense at which she has had to expend, Mayor Hewitt agreed to go out to her property with Councilman Ramsey, and Jamin Beisiegel, Division of Water Management Superintendent, to view her property and see if they all could come up with a solution to her water problem.
