READING AND CORRECTING JOURNAL - of the minutes of the Regular meeting on May 4, 2020

UNFINISHED BUSINESS:

ORDINANCE#12-2020

AN ORDINANCE OF THE COMMON COUNCIL OF PERU, INDIANA, AUTHORIZING THE ISSUANCE OF THE CITY OF PERU, INDIANA TAXABLE ECONOMIC DEVELOPMENT REVENUE BOND OF 2020 (YMCA/TRAIL PROJECT), AND THE USE OF PROCEEDS THEROF TO SUPPORT THE YMCA PROJECT, AND AUTHORIZING AND APPROVING OTHER ACTIONS IN RESPECT THERETO

Jim Tid of Mecda appeared with the attorney who prepared the bond agreement to answer questions regarding the issuing, handling, and liability for repayment of this bond used for the purpose of providing money to help with the development of the YMCA and Nickel Plate Trail. The Chairman of the Council requested that they be allowed more time to read through the material given to the council as it was not sent in sufficient time prior to the meeting to go through all of the agreement. Chairman Gustin also stated that it had been changed from the first copy sent for them to consider. After many questions from Council members it was decided to go ahead and put it to a vote. However, before

voting Mr. Tid was asked if there would be an accounting to the city for how the money was being spent. Mr. Tid agreed to provide a monthly statement to the city clerk/treasurer to be reported to the council for review of how the bond money was being disbursed.

Chairman Gustin made the motion to adopt, seconded by Councilman Anderson. Roll call vote was taken and motion was passed with: 6 Ayes 0 Nays

The discussion to review the applications for the Peru Utility Board vacancy was moved to next months meeting to allow time to advertise the opening.

RESOLUTION#9-2020

CITY RESOLUTION TO ESTABLISH RATE TRACKING FACTOR FOR THE MUNICIPAL ELECTRIC UTILITY FOR THE CITY OF PERU, INDIANA

Motion made to consider Resolution#9-2020 was made by Chairman Gustin, seconded by Councilman Anderson.

Joshua Chance, General Manager of the utility gave an overview of the rate tracker after which Chairman Gustin moved to adopt Resolution#9-2020, seconded by Councilman Sahaidachny. Roll call vote was taken: 6 Ayes 0 Nays

MOTION CARRIED

A completed ADA Transition Plan was submitted for approval by Ashley Lowe. Motion to approve the plan was made by Chairman Gustin, seconded by Councilman Sahaidachny. Roll call vote was taken and approved.

COMMUNICATIONS:

Josh Chance, General Manager of Peru Utilities, presented to the council an resolution that will involve the ability of the utility to collect money owed that accrued during the Coivd event. The people that have an outstanding balance will be able to set up a payment plan to get caught up on the money they owe in a 90-day time period beginning in July and ending the last of October. The utilities will resume will disconnections using their former protocol in Issuing a disconnect.

Councilman Ramsey expressed his condolences to the Terry Alley family on his passing. Mr. Alley was the former council seat that Councilman Ramsey now occupies.

Councilman Sahaidachny asked the Mayor if he thought any of them should be in attendance downtown on Saturday for the planned protest march at the courthouse. The Mayor sald he really didn't think it was a good idea and probably would not suggest going down there.

Mayor commented on the parade held for the seniors on the previous Friday and reported that it was a really good thing the people did for the seniors who would have been at the school at that time for their actual graduation walk but was cancelled due to the pandemic. Mayor Hewitt thought it would be a nice thing to do annually even if they can go through the usual ceremony at the school.

Councilman Sahaidachny asked about how a few of the rough railroad crossings could be fixed. Chief Hawk stated that there are crossings scheduled to be under repair soon.
