The Common Council of Peru, Indiana met in regular session by zoom, called to order by Mayor Hewitt at 6:03 p.m. on February 1, 2021. The following members were in attendance: Tom Gustin, Patricia Russell, Peter Sahaidachny, Kathleen Plothow, Mark Ramsey, Steve Anderson, and Betsy Wolfe, all by video.

Others present were, City Attorney Dustin Kern by video, City Clerk/Treasurer Susan Rylands, department heads, and other interested parties.

ROLL CALL: Anderson, Gustin, Plothow, Ramsey, Russell, Sahaidachny, Wolfe, and Plothow were all present.

READING AND CORRECTING JOURNAL- of the minutes of the Regular meeting on January 4, 2021 Motion to accept the minutes with addition of liaison assignments was made by Tom Gustin, seconded by Steve Anderson. Roll call vote taken with 7 Ayes 0 Nays. Motion Carried.

Council Liaisons Communications:

Kathleen Plothow, not a liaison for Civic Center, expressed her concern for the heat not working properly and fearing frozen pipes at the building. Kathleen was informed that the building was heated and was being checked regularly. Kathleen asked Tom Gustin to join her on a committee for the Police and Fire Pension, with Tom accepting. Kathleen reported that, per MCEDA, the Seven Pillars Brewery was about to be finished.

Mark Ramsey reported that the jail had a new fire wall installed. He also reported that Dr. Redman was resigning and leaving the Miami County Health Department. On other county news Mark reported that the Square D building was in planning to be demolished.

Besty Wolfe and Pat Russell both toured the new AZI building during the open house.

Pat Russell reported that the Aviation Board held their annual election and re-elected all current officers to their current positions. Pat also reported that the board was currently working on a power point presentation for the council in a future meeting. Pat stated that due to covid the Civic Center meeting was postponed to a later date.
