The Board of Public Works and Safety of the City of Peru, Indiana met in regular session, by zoom, at 5:00 pm on March 2, 2021 with the following members present: Mayor Hewitt, Board Member Bill Gornto, and Board Member Ron Dausch. City Clerk -Treasurer Susan Rylands with City Attorney Dustin Kern and other interested parties and department heads were present.

Motion was made by Ron Dausch, seconded by, Bill Gornto to suspend the rules and dispense with the reading and correcting of Journal of minutes of regular meeting on February 2, 2021 and accept the minutes as written.

It was determined that the tree was in the tree lawn and the owner's responsibility for maintaining the tree. Tom Lennon was advised that he did have the right to trim any overhanging branches that was directly over his property line. Any other branches at this point would be the responsibility of the property owner of the tree lawn containing the tree. The city would continue to monitor this issue and make future recommendations as it becomes necessary. Motion to deny the request for tree removal by the city was made by Ron Dausch, seconded by Bill Gornto.
