The Board of Public Works and Safety of the City of Peru, Indiana met in regular session, by zoom, at 5:00 pm on March 16, 2021 with the following members present: Mayor Hewitt, Board Member Bill Gornto, and Board Member Ron Dausch. Lionel McNeil, on behalf of Hometown Ice Cream, would like permission to set up and serve ice cream in the parking lot of the Riverwalk Parkway. He stated he would like to start in mid-April and set up every other Wednesday through September. Board members asked to see if he had more information about the truck he would serve out of and was provided the website. A motion was made to table this request, until the board had a chance to check out the website and see what was being utilitized, which was seconded by Bill Gornto.

MOTION TABLED

Chief Hawk appeared in person the recommend to the board for their approval two new hires for the fire department. Chief Hawk read two letters, one each for each new recruit, to the board stating this would be contingent on both getting approval from PERF. The hire date for both recruits will be March 19, 2021. Each will serve a two year probationary period before being considered for permanent status. The motion was made by Bill Gornto, seconded by Ron Dausch, to approve the hiring of Christan Fulton, and Joshua Schaeffer.

Chief Hawk had an additional request that Nathan Shively be promoted to the position of Inspector for the Peru Fire Department, moving from his position as Mechanic. Chief Hawk read the letter written by Nathan stating his qualifications and certification of Inspector 1 and Inspector 11 earned in July 2020. Motion was made to approve the move from Mechanic to Inspector by Ron Dausch, seconded by Bill Gornto.

During communications Betsy Wolfe asked both Fire Chie Hawk and Police Chief Sofinanos how many each department was still short on manpower with both Chiefs providing her with an update on the current status of how many was in process and how many would still be needed. Besty also stated that in the request for the ice cream vendor from Kokomo that they consider the competition to the local businesses who pay taxes to the city.
