ROLL CALL: Anderson, Gustin, Plothow, Ramsey, Russell, Sahaidachny, and Wolfe were all present.

READING AND CORRECTING JOURNAL- of the minutes of the Regular meeting on September 13, 2021. A motion to accept the minutes was made by Russell, seconded by Gustin. Roll call vote was taken with 7 Ayes and 0 Nays.

MOTION CARRIED

COUNCIL LIASION COMMUNICATIONS:

Russell reported on the Aviation and Planning Commission were cancelled. Peru Utilities Board met, and Civic Center was cancelled.

Plothow reported on a committee and that she was planning on attending a conference for MCEDA on October 28, 2021.

Ramsey reported on four dogs at the Animal Control, Street Department congratulations on doing a good job, with the Peru Utilities having their fall Riverbank Cleanup Event on Saturday, October 16, 2021, from 9am to noon. Miami County Commissioners approved the nine year contract for the Eagleview Reassessment for Miami County. Gustin, Anderson, Sahaidachny and Wolfe had nothing to report.

ORDINANCE FOR APPROPRIATIONS AND TAX RATES

Motion was made by Wolfe and seconded by Plothow to open discussion. Roll call vote with 7 Ayes and 0 Nays. (Gustin stepped back in)

Motion to remove the ARP money from the budget was made by Wolfe, seconded by Plothow. Roll Call vote was taken with 4 Ayes and 3 Nays. **Motion Carried**

Motion was made by Wolfe, seconded by Plothow to remove the vehicle for the building department from the budget. Roll call vote was taken with 2 Aye and 5 Nays. **Motion Denied**

Motion was made by Wolfe, seconded by Plothow to remove the vehicle for the Fire Chief from the budget. Roll call vote was taken with 3 Ayes and 4 Nays. **Motion Denied**

Motion was made by Wolfe, seconded by Plothow to have only three vehicles, not four in the budget for the police. Roll call vote was taken with 4 Ayes and 3 Nays. **Motion Carried**

Motion was made by Wolfe, seconded by Plothow, to reduce the financial fees to \$20,000. Roll call vote was taken with 2 Ayes and 5 Nays. **Motion Denied**

Motion to reduce Beautification from \$150,000 to 50,000 was made by Wolfe, seconded by Plothow. Roll call vote was taken with 6 Ayes and 1 Nay. **Motion Carried**

Motion was made by Anderson, seconded by Ramsey to adopt. Roll call vote was taken with 6 Ayes and 1 Nay. **Motion Carried**

ORDINANCE #20-2021

Motion was made by Wolfe, seconded by Plothow to take out the salary for the mayor's secretary. Roll call vote was taken with 1 Ayes, and 6 Nay. **Motion Failed**

Motion was made by Wolfe, seconded by Plothow to take the raise from the city attorneys' salary and put it back to 2021 salary. Roll call vote was taken with 2 Ayes, and 5 Nays. **Motion Failed**

Motion was made by Wolfe, seconded by Plothow to take the raise from the Building Commissioner and put it back to the 2021 salary. Roll call vote was taken with 2 Ayes and 5 Nays. **Motion Failed**

Motion was made by Wolfe, seconded by Plothow to take the raise from the Fire Chief and put it back to the 2021 salary. Roll call vote was taken with 3 Ayes and 4 Nays. **Motion Failed**

Motion was made to amend the wage ordinance to make two changes in section 6 to have the wording match the numbers by Russell, seconded by Ramsey. Roll call vote was taken with 7 Ayes and 0 Nays.

Motion was made by Wolfe, seconded by Plothow, to take the raise from the city judge and return the salary back to \$13,850. Roll call vote was taken with 3 Ayes and 4 Nays. **Motion Failed**

Motion was made to adopt Ordinance #21-2021 by Gustin, seconded by Ramsey. Roll call vote was taken with 5 Ayes and 2 Nays. **Motion Carried**
