Motion to accept the payment of Regular Payroll, in the amount of \$182,097.06 was made by Board Member Jelenek, seconded by Mayor Hewitt. All said Aye.

Motion to accept the payment of the OPO Payroll, in the amount of \$4,623.22 was made by Board Member Jelenek, seconded by Mayor Hewitt. All said Aye.

OLD BUSINESS:

The Building Department announced the winning bid to raze all structures at 30 W. 10th Street, Peru, Indiana was to be awarded to Down N' Dirty for the bid amount of \$7,554.

Motion to accept the bid award was made by Jelenek, seconded by Mayor Hewitt. All said Aye

NEW BUSINESS:

Motion was made to amend the agenda to add the consideration of adoption of the agreement between the City of Peru, and the Firefighters Local 383, at the end of the new business, by Jelenek, seconded by Mayor Hewitt. All said Aye. MOTION CARRIED

Chasity Combs, on behalf of Riverside Grill & Lounge, LLC requested a road closure next to the building on Riverside Drive on June 8th, 9th, 10th, and 11th for the Cole Porter Festival.

After a brief discussion with the Fire Chief and Chief of Police the motion to approve the request was made by Mayor Hewitt, seconded by Jelenek. All said Aye.

James Loft, on behalf of Peru Ministerial Association, requested placement of "Ten Commandments" monument on property which is portions of lots 147 and 148 in the original plat of the City of Peru, Indiana.

It was stated that the property is leased by the City of Peru and the monument was not a permanent fixture. The motion to approve the request was made by Mayor Hewitt, seconded by Jelenek. All said Aye.

Chief Sofianos, on behalf of the Peru Police Department, requested to hire one Police Officer.

Andrew Dougherty successfully completed the hiring process and would receive benefits as if he had started December 12th 2020 at the Peru Police Department as an officer. Mr. Dougherty's hire date would be May 2, 2022 and have a year probation period. His seniority within the department will start on May 2, 2022 if approved.
