11:33am. Meeting called to order- Antonia Sawyer requested everyone introduce themselves and sign in on sheet provided. Each member introduced themselves.

11:35am: Antonia sawyer placed strategic plan up on monitor and went through it, there were no objections to the strategic plan. Debi Wallick of the United Way of Miami County motioned to move forward with the plan, Brian VanCamp of AA/NA seconded the motion. All members were in favor, there were no oppositions.

11:50am. Debi Wallick opened up the updates with information on the "Miami County Works" program. There has been over 30 participants in the 5 classes provided, with referrals coming from DCS, Community Corrections, Circuit Court, and self-referrals from community. The workgroup has expanded to a youth workshop set for June 6, 2017 @ 5:30pm.

Brian VanCamp presented the report on the Narcan training held May 6, 2017. There were 26 community members trained, 29 Narcan kits distributed, 29 medication lock bags distributed. Discussion opened around the group. Wendy asked if SOCGC was "okay" with the attendance, and Brian voiced that the relocation due to the YMCA not wanting the training around the kids fair did a disservice to the community, and hurt attendance. Heidi voiced that SOCGC needs to continue with future

trainings to continue to reduce stigma around substance abuse. Diana Berich voiced a positive interaction with each individual whom attended, and that they varied in ages and appeared to be family members. Diana voiced supportive and happy comments/feelings around the training from those whom attended.

Angela Bever spoke on the community update held on April 27, 2017. Angela voiced a smaller attendance but valuable conversation. Antonia asked Angel to speak on "Chemi/Kemmy" and she was able to repeat what was said at the event. Angela spoke to the fact that "Chemi/Kemmy" is dissolved in a solution and then sprayed on Spice or other substances. It is not easily detectable on a drug screen and therefore is popular with probationary clientele. The drug will cause an intoxicated or drunk type high. Kenny voiced several parents of his students are struggling with "Chemi/Kemmy" currently. Chief thanked Angela for informing him of more than he had previously known about the substance.

Wendy Langer updated the members on "Living Free" as well as spoke from a flyer provided by Pastor Phil Bunce, and those were distributed for reference. Connie Shapiro requested more copies of the document, and Antonia stated she would scan and forward with minutes and current contact list.

Heidi Wright spoke on domestic violence and sexual assault. Heidi held an event for the viewing of "Audrie and Daisy" a documentary about two youth who were sexually assaulted after using alcohol. Letecia voiced concern about youth watching such films without parental/adult support. Kenny spoke that several of his students has seen the film prior to the event. Kenny also spoke to new legislation that was being implemented which included mental health training for students and staff yearly.

Chief Meeks spoke on a Narcan success story, and how an individual cried to him that he was saved and found sobriety after Narcan. the sharps containers provided by Dukes Memorial Hospital to assist the PPD in properly disposing of sharps as needed. A lot of diabetic needles and some substance use needles have been disposed of or found by the PPD. Chief encouraged anyone who finds a needle to call PPD/9-1-1 to have it disposed of, due to the drug Fentanyl being so strong, it could absorb in the skin and cause overdose or illness.

Jennifer Yates spoke on the SAPC Recover Month Celebration- it will be September 16, 2017 @ 10:00am-2:00pm. More information is to come.

Nicole Hyatt-Drang spoke on a pilot Vivitrol program that will be available to Miami County residents in early summer. CJ Davis, President/CEO of Four County Counseling Center will present information to the community at the SOCGC meeting on June 13, 2017 @ 11:30am.

Dale Bliss spoke on Advantage Housing and a rapid rehousing opportunity for Miami County. This would afford a resource to those whom are homeless in our community. A motion made by Peter Diedrichs and second by Connie Shapiro to move forward with pursuing this opportunity was made. David Smith and Pastor Lauren Hall then requested to be on the workgroup to move this forward.

Kenny Hanson spoke that "Remedy Live" will be performing at PHS on August 21, 2017 and the planning meeting will afford more information.
