11:34am: Introductions of all in attendance; Jacob Grady volunteered to take notes.

11:35am-11:50am- Steve Hatland presented “Fatherhood Engagement” and led a short discussion on the program. The program is currently in Grant County and is looking to expand into Miami County. The program focuses on anger management, father engagement with tier children, stress issues, helps model behaviors for fathers, increased empathy, lower mental health issues, and substance use issues when fathers are engaged.

11:55am: “Sticky Note Showdown” began as group looked for ideas on creating a Mission and Vision Statement. As well as a name for the recovery scholarship. Ideas for new location and Fatherhood Engagement workgroup were also accepted.

12:15pm-1:00pm: The group discussed new ideas for Mission and Vision. The Mission Statement was voted on unanimously, and reads as:

*“A coalition that will create a caring community with the resources to prevent and treat: substance use, substance abuse, and mental health needs”*

The scholarship name was voted on and reads as: “The Miami County Cares” scholarship. It was also voted unanimously that SOCGC will not change its name.
