Narrative

(a) Project Plan for Opioid Rescue Kits

Project name: Miami County Naloxone (NARCAN) Initiative Miami County Naloxone Initiative Training Plan: The Miami County Health Department will conduct weekly community trainings within the Miami County Health Department building, located at 35 Court Street, Peru, IN. 46970. Trainings will be held on each Wednesday of each week between 11:30am to 12:30pm; between the dates of September 15, 2017 and April 30, 2017. Resulting in 10 trainings between the dates of September 15, 2017 and December 1, 2017, 12 trainings between the dates of December 1, 2017 and March 1, 2018, and 12 trainings between the dates of March 1, 2018 and May 31, 2018. Producing a total of 34 scheduled in office trainings annually. The Miami County Health Department will also include one first quarter community training event and one third quarter community training event; both to be conducted outside of the Miami County Health Department at a local community event center. These training will be held during scheduled hours available by the center used. Producing 2 community centered trainings annually, which will be in replacement of one Wednesday training between the dates of September 15, 2017 to December 1, 2017 and March 1, 2018 to May 31, 2018. The training plan will be based on the Optin.in.gov training tool kit, and include education material on opioid misuse, overdose, prevention and treatment. The Miami County Health Department is currently registered as an entity to distribute Naloxone with Optin.in.gov. and will renew registration yearly as required. Antonia Sawyer will register on August 15, 2017 and await approval. (i) Partnering agencies with health department to help train and distribute Naloxone; Amboy Fire Department of Miami County, Antonia Sawyer, BS., Denver Fire Department of Miami County, Grissom Fire Department of Miami County, Indiana Department of Natural

Resources, Peru Division.; Indiana State Police- Peru Division, Macy Fire Department of Miami County, Mexico Fire Department of Miami County, Peru Police Department, Pipe Creek Fire Department of Miami County, Miami County Sheriff Department. (b) High risk areas within the service area include all of Miami County. Overdose in progress calls to Miami County Dispatch have increased from 18 in 2014, to 32 in 2015, and 62 in 2016. There has also been an increase in overdose deaths within Miami County; rising from 6 deaths in 2013 and 2014, to 14 in 2015. Non-fatal emergency department visits, due to opioid overdose, totaled 41 visits in 2015. Miami County law enforcement 2016 data reflects that of 14 calls requiring the administration of Naloxone, 21 doses were used. Averaging 1.5 doses per response, prior to EMS arriving. Miami County currently ranks in the top 30 counties in the state for soft tissue infections associated with drug use/abuse, and top 15 counties for Endocarditis; a bacterial infection related to IV drug use. Miami County has a 1 to 1 ratio for opioid prescription medications, while the state of Indian resides in the top 10 highest nationally for opiate prescriptions; with a 1.09 to 1 ratio. Miami County also reflects a low health ranking in mental wellness, household income, and emergency department visits. (c) Target Distribution Points: Lay responders within the community of Miami County, as well as agencies listed in specific "partnering agencies" area in section (a). (d) The estimated quarter one distribution will be 27 total kits distributed to targeted distribution points not including lay responders, and 56 total kits distributed to only lay responders; estimated quarter two distribution will be 27 total kits distributed to targeted distribution points not including lay responders, and 56 total kits distributed to only lay responders; estimated quarter three distribution will be 28 total kits distributed to targeted distribution points not including lay responders, and 56 total kits distributed to only lay responders -totaling 250 kits annually. This estimate was determined from a 250 kit request, divided 33% for distribution points outside of

lay responders, and 67% for lay responders only; over 3 quarters. The Miami County Health Departments (e) data collection plan is to have an Excel spreadsheet to be updated weekly, after each in office training session. This will reflect the number of kits distributed, which location (health department or community center) was utilized, and how many utilized the free medication lock bag option (co-offered service). Kits distributed to other distribution points outside of lay responders, will also be reflected here. (f) Methods for educating the community on the availability of Naloxone and the required education before distribution will be through the utilization of newspaper press releases, social media, local committee presentations, community bulletin board posting sites, air on local radio stations, and community events. (g) Challenges and/or barriers regarding Naloxone distribution that present themselves will be addressed through open communication with Miami County Systems Of Care Governance Coalition, The Miami County Department of Health Board, and the Indiana State Department of Health. This communication will afford multiple solutions to issues, continued community collaboration, and guidance as to ensure grant parameters are enforced. Planned reporting requirements will be as follows: 1st. report being submitted prior to January 15, 2018 for quarter one (September 15, 2017-November 30, 2017) 2nd. Report being submitted prior to March 30, 2018 for quarter two (December 1, 2017-February 28, 2018) and 3rd. report being submitted prior to June 30, 2018 for quarter three (March 1, 2018-May 31, 2018)

The Miami County Health Department and the Systems Of Care Governance Coalition hereby

agree to provide quarterly project reports as stated above, during the period of service delivery.
