OLD BUSINESS:

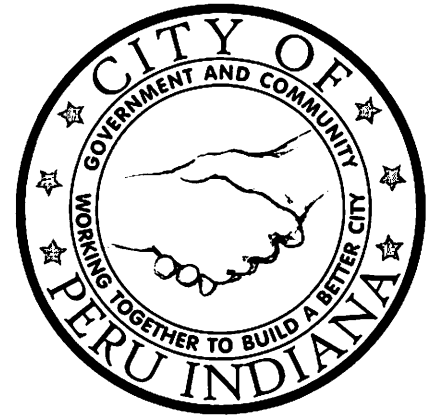
- Vacation a portion of Darrow Street located between addresses 140 W Boulevard and 152 W Boulevard
